**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

➤ **Statement of Needs:**

Currently there are **35** families on the Section 8 waiting list for rental assistance. The statistical information gleaned from the waiting list includes the following:

**28** have incomes under 30% of the HUD's extremely low income guidelines.

**6** of the wait list are at or below 50% of HUD's very low income guidelines.

**1** of the wait list are at or below 80% of HUD's low income guidelines.

**20** of the wait list have children.

**4** of the wait list are elderly and **11** are handicapped/disabled.

**28** are white **4** are African/American **3** are Hispanic

➤ **Strategy for Addressing Needs:**

The strategies for addressing the housing needs of families in the jurisdiction and on the waiting list come in the form maintaining a waiting list that is open. Applicants are pulled off the waiting list on a first come first serve basis. UERHA monitors lease-up and utilization monthly and with the assistance of a fee accountant, Loucks and Swartz hired most recently, this is better monitored. UERHA will apply for additional Vouchers should they become available. Other housing sources will be pursued such as State Tenant Based Rental Assistance and Security Deposit Assistance. Outreach efforts through agencies that serve the same clientele, such as: Department of Human Services, Northeast Iowa Community Action and NEI3 will continue.

Landlords are encouraged to provide housing contact information which is supplied to tenants with briefing packets or when making application. Another good source to find housing is through [iowahousingserach.org](http://iowahousingserach.org). through the Iowa Finance Authority Website.

The UERHA also provides Language Translation Services to those needing assistance.

➤ **Consolidated Plan:**

In accordance with the March 31, 2016 Final State Consolidated Plan UERHA will strive to provide ensure applicants can obtain affordable housing in Allamakee, Clayton, Fayette, Howard and Winneshiek County (excluding Decorah).

The 2015-2019 goals stated throughout the State of Iowa Consolidated Plan is the creation and preservation of affordable rental housing. The 5-year expected outcome stated in the consolidated plan is 65 new construction units and within 1 year, 13 new construction units. For rental rehabilitation, the 5-year expected outcome is 50 rental units rehabilitated and the 1 year outcome is 10 units rehabilitated. It is also expected that within 5 years that 1,875 Tenant Based Rental Assistant (TBRA) Units will be funded through Iowa Finance Authority and within the next year an additional 375 more units will receive funding.

- Upper Explorerland RHA implemented a Section 8 Homeownership program and currently one family is purchasing a home through this program. Northeast Iowa Community Action provides homeownership counseling classes. UERHA will continue to promote the homeownership program.
- The Violence Against Women Act (VAWA) rules have been implemented. UERHA continues to provide contact information for participants that are in need that includes but is not limited to the following agencies: Helping Services, Cedar Valley Friends of the Family and the Great Rivers Resource Center.
  - Goal: Provide a safe environment for all HCV Families.
  - Referrals: Refer victims of domestic violence, dating violence, sexual assault or stalking to: Helping services 1-877-7Youcan, Turning Point Rural Housing Project 1-800-410-72-33. Great Rivers 211 or 1-800-362-8255 Resource Center 1-800-383-2988. UERHA will maintain partnerships with the same goals to keep families free from violence.
  - Activities:
    - ❖ Brochures will be provided to all landlords and tenants making them aware of the Violence Against Women Act (VAWA)
    - ❖ Information about organization will be provided in briefing packets
    - ❖ Lease addendums included with leases and contracts
    - ❖ Procedures for handling claims of victims of domestic violence status by participants explained at briefing and annually.
- Continue to be a high performer on SEMAP; UERHA scored 100% on SEMAP this year.
- Continue outreach efforts to landlords by promoting [iowahousingsearch.org](http://iowahousingsearch.org). through a website put together by Iowa Finance Authority. This site offers landlords an opportunity to list properties and prospective renters a broad range of units statewide in which to find available housing. UERHA maintains a landlord list to provide to applicants who are in search of housing in our jurisdiction. This is provided in briefing packets or upon request.
- Continue to ensure equal opportunity and affirmatively further fair housing. RHA staff continually attend training when offered. UERHA will attend training in April of 2017 at NAHRO, training to be put on by HUD Director, Betty Bottiger.
- Explore the expansion of assisted housing by potentially applying for Tenant Based Rental Assistance through Iowa Finance Authority.
- Continue to maintain a lease rate of 407 units per month based or more if budget authority allows.
- Language Services or Translation Services are provided to those needing assistance. This service was provided as of 06/01/2015.
